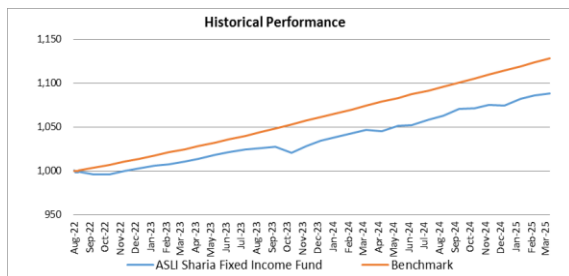

MARKET UPDATE

The bond market took a turn for the worse, corrected -0.17% MoM despite the year-to-date positive performance of 1.95%. The Government Sukuk index (IGSIX) decreased by 0.01% MoM. Indonesia benchmark series 13 years' sharia government bond yield (PBS034) increased by 6.9 bps to 6.84%. In March 2025, BI middle rate was depreciated 0.95% to 16,588/USD. Initially, the bond market was quite resilient, as seen from the incoming demand in the regular government bond auction which rose to the third highest level in 2025, with investor participation also still quite good. However, the delayed release of the state budget report by almost a month and the rumour that a minister would resign from the cabinet created turmoil in the domestic market. Furthermore, in the midst of Ramadhan and ahead of the long Eid holiday, investors tended to reduce risk in the market, and overall made bond yields rise at the end of the month. From the primary market particularly regular government bond auctions, demand in SUN auctions declined, lower than the 2025 average demand of IDR64 trillion, while demand for SBSN auctions increased, slightly higher than the 2025 average bid of IDR21 trillion. Meanwhile, although BI eventually maintained its benchmark interest rate level, SRBI rates continued to decline with the 12-month SRBI weighted average yield at 6.43%.
