As per 31 December 2024, the Risk Based Capital ratio of PT Asuransi Jiwa Astra reached 293% with unit link fund assets and pension fund assets amounted to Rp 3.86 trillion and Rp 3.75 trillion respectively.

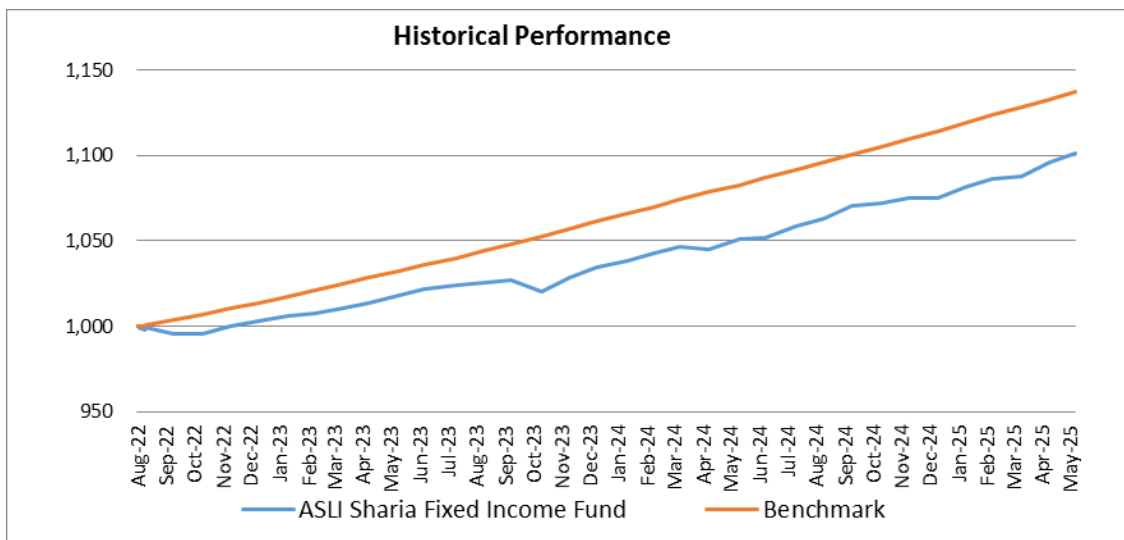

MARKET UPDATE

In the fixed income market, The Government Sukuk index (IGSIX) increased by 0.58% MoM. Indonesia benchmark series 13 years' sharia government bond yield (PBS034) increased by 2.2 bps to 6.86%. Foreign investors posted a whopping Rp21.7tn net buy in IndoGB and percentage ownership is maintained at 14.5%. Domestic investors also posted net buy in the month of May helping to support yield. Consistent with BI easing policy, Sekuritas Rupiah Bank Indonesia ("SRBI") rates were down to 6.2-6.3% level for 12-month tenor. One-year government bond rallied by 9bps to 6.07%, the 2-year bond also rallied by 19bps to 6.17%. In the money market funds, investments in bond maturing less than one year remains favourable compared to deposit rates. Large maturing SRBI in May likely helped with demand from Banks, and the trend likely to continue in June and July assuming Rupiah does not depreciate significantly.

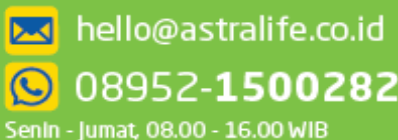
