

MARKET UPDATE

Bank Indonesia (BI) reduced its policy rate by 25 basis points to 5.50% during the May 2025 meeting, marking its second cut since January. BI indicated that the rate cut aligns with its efforts to ensure inflation remains within target while supporting economic growth. Bank Indonesia also revised its GDP forecast for 2025 to 4.6% - 5.4%. Headline inflation moderated to 1.6% YoY in May from 1.9% in April, falling short of the expected 1.9%. This decline was accompanied by a 0.4% MoM deflation, and was mainly attributed by a significant drop in prices for food and beverages. In May 2025, BI middle rate was appreciated 3.27% to 16,255/USD.
