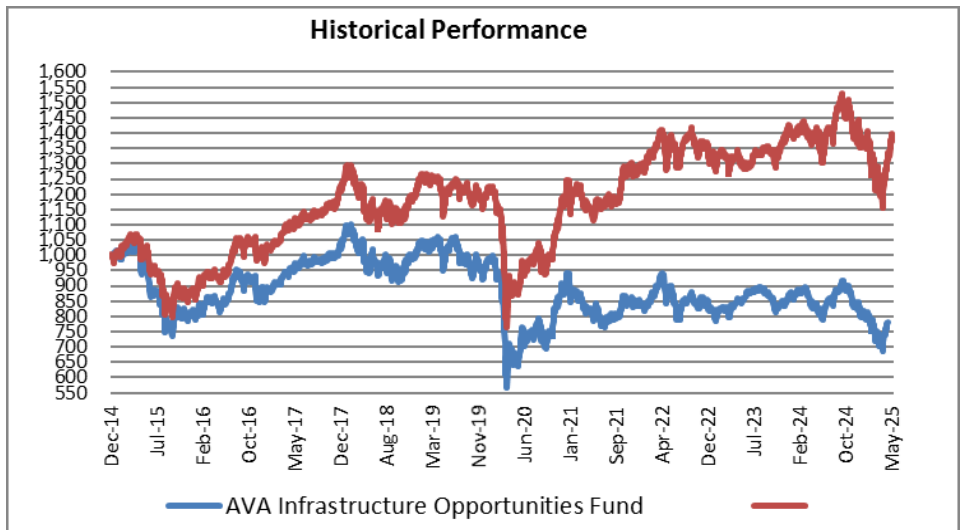

MARKET UPDATE

In the month of May, JCI posted a return of +6.04% MoM with foreign inflow of Rp5.5tn. Indonesia equities continued its rally driven by easing sentiments regarding Trump's tariff as the US President seemingly toned-down pressure on his tariff war. Hence, blue chip names rallied and led the market gain. Strong gold price continued to support the gold proxy names. Rupiah recovery during the month also fuel the market rally during the month. Meanwhile, Bank Indonesia managed to cut rate by 25bps as a result of the strong Rupiah.
