MARKET UPDATE

In the fixed income market, The Government Sukuk index (IGSIX) increased by 0.98% MoM. Indonesia benchmark series 13 Years' sharia government bond yield (PBS034) decreased by 6.5bps to 6.79%. BI unable to further cut rates in June as the meeting was held too close to Israel-Iran escalation hence BI was in a "wait-and-see" mode. Foreign investors posted a net sell of Rp7.6tn in IndoGB and percentage ownership is maintained at 14.56%. Sekuritas Rupiah Bank Indonesia ("SRBI") rates remained at 6.2-6.3% level for 12-month tenor. One-year government bond rallied by 25bps to 5.80%. In the money market funds, investments in bond maturing less than one year remains favourable compared to deposit rates. Large maturing SRBI in June likely helped with demand from Banks, and the trend likely to continue in July, assuming Rupiah does not depreciate significantly. In June 2025, BI middle rate was appreciated 0.14% to 16,233/USD.
