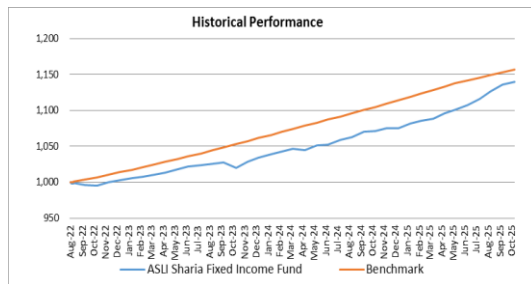

MARKET UPDATE

During October 2025, The Government Sukuk index (IGSIX) increased by 2.15% MoM and Indonesia benchmark series 13 years' sharia government bond yield (PBS034) decreased by 26.7bps to 6.30%. BI decided to maintain the BI rate at 4.75%, against market expectations of cut. During the meeting, BI still signaled dovish messages and eased Required Reserved Ratio policy, but in the future the main focus will be on strengthening monetary policy transmission, especially at lending and deposit rates. On the fiscal side, the MoF announced that monthly fiscal deficit on Sept-25 is still under control at -1.35% of GDP, amid the risk of a slowdown in revenues. The market responded positively to the government's ad hoc stimulus of IDR 30tn, which was the catalyst to boost economy in Q4-25. In October 2025, BI middle rate was appreciated 0.24% to 16,640/USD.
