As per 31 December 2024, the Risk Based Capital ratio of PT Asuransi Jiwa Astra reached 293% with unit link fund assets and pension fund assets amounted to Rp 3.86 trillion and Rp 3.75 trillion respectively.

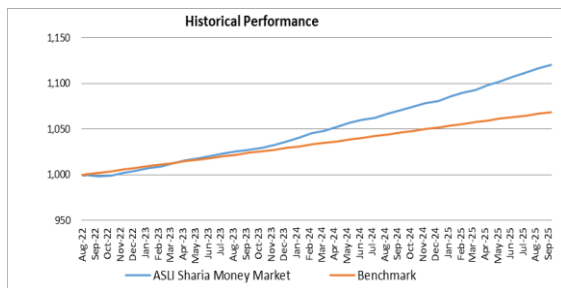

MARKET UPDATE

Indonesia headline inflation rose sharply to 2.9% YoY in October from 2.7% in September, higher than the consensus estimate of 2.6%, driven mainly by personal care and other services. On a monthly basis, CPI increased 0.3% MoM, up from 0.2% in September, reflecting stronger personal care and other services inflation at 3.1% MoM (vs. 1.2% previously). Consequently, core inflation edged up to 2.4% YoY from 2.2%, against expectations of a stable outturn. Bank Indonesia kept its policy rate unchanged at 4.75% after three consecutive cuts, against consensus expectations of another 25bp cut. BI shifted its focus toward improving monetary policy transmission, emphasizing the need for banks to accelerate lending rate reductions to support growth. Indeed, BI opted to ease macroprudential policy by providing incentives for lending rate cuts. However, BI reiterated that there remains room for additional rate cuts ahead. In October 2025, BI middle rate was appreciated 0.24% to 16,640/USD.

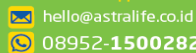
