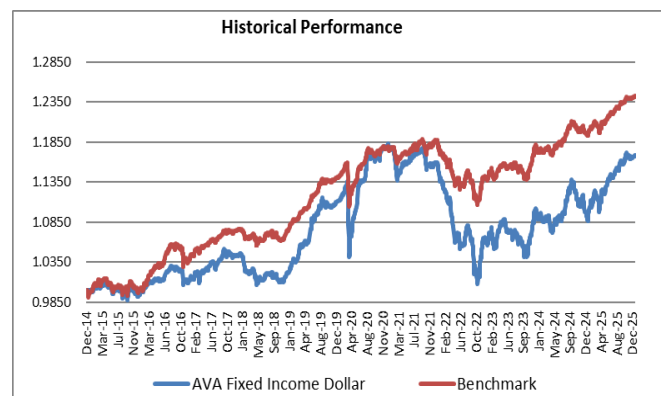

The US 10-year treasury note yield increased by 16 bps to 4.18% by the end of December 2025 and Indonesia 10 years USD global bond yield remained unchanged, remaining at 4.88% at the end of December 2025. Thus, the spread widened.
