As per 31 December 2024, the Risk Based Capital ratio of PT Asuransi Jiwa Astra reached 293% with unit link fund assets and pension fund assets amounted to Rp 3.86 trillion and Rp 3.75 trillion respectively.

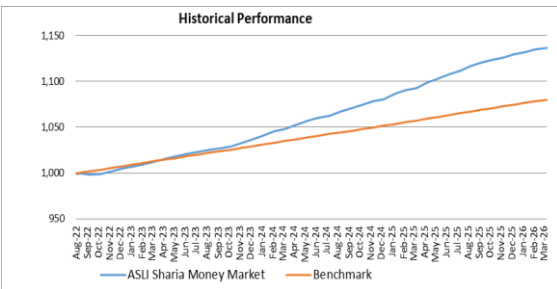

MARKET UPDATE

Indonesia's annual inflation eased to 3.48% in March 2026 from 4.76% in the previous month and falling short of market expectations of 3.60%. Core inflation, which strips out volatile food and administered prices, dropped to 2.52%, below February's figure and forecasts of 2.63%. Bank Indonesia (BI) held its policy rate steady at 4.75% during its March 2026 meeting, in line with market expectations. The decision aims to bolster the stability of the Rupiah while keeping inflation within the central bank's 2026-2027 target of 2.5% ±1%. The Rupiah weakened, as escalating Middle East tensions triggered capital outflows from emerging markets. In March 2026, BI middle rate was depreciated 1.38% to 16,993/USD.
