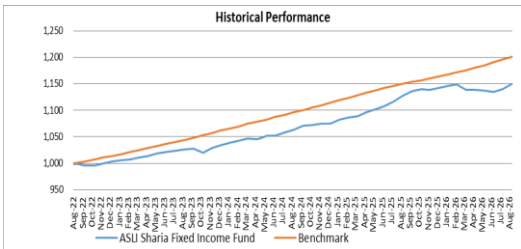

MARKET UPDATE

Indonesia's bond market recorded positive performance in August 2026. The Government Sukuk index (IGSI) increased by 1.87% MoM and Indonesia benchmark series 13 years' sharia government bond yield (PBS034) decreased by 12bps to 7.10%. Domestically, the market responded positively to the appointment of Destry Damayanti as the sole candidate for Governor of Bank Indonesia. In the fit and proper test process, Destry pledged policy continuity and close coordination with the government while preserving Bank Indonesia's (BI) independence. On the other hand, the market also responded positively to the government's commitment to maintaining the 2027 state budget deficit. The government is targeting a state budget deficit of 2.4% of GDP, with a plan to optimize core tax from the revenue side and further efficiency efforts from the expenditure side. Other positive sentiments came from the improvement in domestic liquidity, driven by the government's SAL injection and the reduction in the frequency of SRBI auctions. In August 2026, the ministry of finance again conducted a SAL injection to the banking sector with a total of IDR 70tr, which also improved domestic liquidity conditions. Simultaneously, BI decided to reduce the frequency of SRBI auctions to biweekly and change the rule to only allow banks and foreign investors to purchase SRBI. On the other hand, the market is still worried about the risk of inflation and the widening of the current transaction deficit. In August 2026, BI middle rate appreciated 2.12% to 17,703/USD.
